

Map production and delineation of safeguarding boundaries
The boundaries of the aggregate safeguarding areas have been defined based on the aggregate mineral resources data that were prepared for and included in the National Minerals Map of Wales. In order to account for the effect of mineral use on the environment, the boundaries of the safeguarding areas have been defined based on the aggregate mineral resources data that were prepared for and included in the National Minerals Map of Wales. These extensions reflect the maximum separation distances between sensitive development and mineral resources that are identified in Minerals Technical Advice Note 1. Aggregates safeguarding areas are not shown in urban areas, which are defined by the Ordnance Survey 'VectorMap Local' dataset launched in 2006.

Reading the map
The maps show categories of aggregate mineral resources according to whether the resource is considered nationally important (Category 1) or important for serving regional and local markets (Category 2). Aggregate mineral resources that are locally important in some areas but which are not used in all areas (Category 2) are not shown on the map, but are resources that have a national importance as defined by the information provided in the Minerals Technical Statements for both from the South Wales and the National Minerals Map of Wales. Category 1 resources are those resources that have a national importance as defined by the information provided in the Minerals Technical Statements for both from the South Wales and the National Minerals Map of Wales. Category 1 resources are those resources that are specifically referenced in policy as being of limited resources and therefore particularly susceptible to variations in the region, and those resources that are particularly important due to their high quality and/or limited occurrence across the United Kingdom. Category 2 resources have been selected as those resources that are considered to be of local importance and may have some regional significance, but are of less importance nationally than those identified for Category 1. The mineral resources that qualify as Category 2 resources were selected by BGS and technical experts in a project steering group, as detailed knowledge of the local industry is necessary to make these judgements.

The map production techniques used for the Aggregates Safeguarding Maps are that surface deposits (sand and gravel) were not shown, and where there are two categories of aggregate resources, Category 1 safeguarding areas cover Category 2 safeguarding areas. Where Category 1 includes aggregate safeguarding areas under surface deposits, aggregate safeguarding areas, a solid line shows the boundary (see surface map in separate map below).

Aims and Limitations
The purpose of this map is to show the areas where aggregate mineral resources are at risk from exploitation. The map only covers resources suitable for use as aggregates. The maps are intended to assist with the distribution of aggregate safeguarding areas in Local Development Plans. The maps show only areas of primary land use aggregates shown in the red map, and do not take into consideration secondary or recycled aggregates, the national policies for which are described in Minerals Planning Policy Wales.

The maps have been produced by the collection and interpretation of aggregate mineral resources data that were prepared for the National Minerals Map of Wales. The mineral resources data that underpin the safeguarding areas are based on the best available geology and other published information, but the available data are not comprehensive and their quality is variable. The areas shown are not of uniform extent; the economic operation of mineral sites can only be proved by a detailed evaluation programme. Such an investigation is an essential precursor to submitting a planning application for mineral working. Extensive areas are shown as having no mineral resource potential, but some isolated mineral workings may occur in these areas. The presence of these mineral workings reflects very local conditions. The presence of an aggregate safeguarding area does not carry a presumption that the mineral will be worked.

The maps are intended for general consideration for aggregate safeguarding purposes and not as a source of information on specific sites. The maps should not be used to determine individual planning applications for working aggregates, or to take other decisions on the acquisition or use of a particular tract of land.
